



## MEMORANDUM OF AGREEMENT

Between

YALA RAJABHAT UNIVERSITY, THAILAND

And

SANICHEM RESOURCES SDN. BHD., MALAYSIA



This MEMORANDAM OF AGREEMENT, made and entered into as of the 12th day of December, 2016 by and between YALA RAJABHAT UNIVERSITY, THAILAND, hereinafter referred to as "YRU" and SANICHEM RESOURCES SDN. BHD., MALAYSIA, hereinafter referred to as "SaniChem". (YRU and SaniChem, shall hereinafter referred to collectively as "Parties" and individually as a "Party")

Both parties agree with the promotion of international collaboration in Academic and Cooperative Education programs and agree to encourage the following activities in particular to promote the Academic and Cooperative Education programs.

1) Collaboration in Cooperative Educational Program

1.1 YRU and SaniChem will have equal responsibility for the program in arranging, implementation, evaluation and official accreditation to certify the program completion.

1.1.1 Provide the appropriate assignments in accordance with student's program

1.1.2 Provide a supervisor for the students during their cooperative education placement with SaniChem;

1.1.3 Provide an interview or criteria to qualify students at least one (1) semester or suitable period before entering the cooperative education program;

1.1.4 SaniChem shall inform the FSTA at least one (1) month before the date of entering program;

1.1.5 An appropriate facility or any remuneration will be in consideration of SaniChem.

2) Other feasible and relevant educational activities

2.1 Joint organization of educational, research program as well as exchange information about conference, workshop and mutual participate in them;

2.2 Supporting activities/ services such as workshop on using the advance analytical instruments, short-term collaboration project are considered;

2.3 Exchange visits of official of both parties;

2.4 Any other areas of collaboration to be mutually agreed upon by the parties.

3) This Memorandum of Agreement shall be effective for three (5) years after the date of signing by the representatives of both parties. Either party may revise or terminate this Memorandum of Agreement by giving thirty (30) days written notice to the other party.
