



MEMORANDUM OF AGREEMENT

BETWEEN

UNIVERSITAS NEGERI YOGYAKARTA, INDONESIA AND YALA RAJABHAT UNIVERSITY, THAILAND

No. B/15.3/UN34.13/IIK.06/2023 On this the 1 day of August 2023

Universitas Negeri Yogyakarta (hereinafter called UNY), represented by Prof. Dr. Ariswan in his capacity as the Dean of Faculty of Mathematics and Natural Sciences Universitas Negeri Yogyakarta (hereinafter "FMIPA Universitas Negeri Yogyakarta"), hereinafter referred to as FIRST PARTY.

Yala Rajabhat University (hereinafter called YRU), represented by Asst. Prof. Nipapat Kunthon in her capacity as Dean of Faculty of Science Technology and Agriculture (hereinafter "FSTA Yala Rajabhat University"), hereinafter referred to as **SECOND PARTY.**

ARTICLE 1 SCOPE OF WORK

Both Parties have agreed to develop educational cooperation on the basis of equality for the guest lecture and credit transfer programs in Chemistry course.

ARTICLE 2 RESPONSIBILITIES

The First Party Responsibilities - shall cover the following provisions:

- 1. Select qualified Chemistry course experts to present a guest lecturer at YRU.
- Schedule and organize the Chemistry course for selected students in credit transfer program at UNY.
- 3. Develop a tailored program in Chemistry (including extra activities) for credit transfer program
- 4. Organize and fund:
 - One-way economy airfare from Yogyakarta to Yala Rajabhat University for guest lecturer from UNY.
 - Provide selected students to act as companion tutors for credit transfer participants.

The Second Party Responsibilities - shall cover the following provisions:

- 1. Select students to participate in credit transfer program in Chemistry course.
- 2. Schedule and organize the Chemistry guest lecture at Yala Rajabhat University.
- 3. Organize and fund:
 - One-way economy airfare from Yala Rajabhat University to Yogyakarta for guest lecturer.
 - Provide suitable accommodation and lump sum for guest lecturer.
 - Provide tuition and accommodation fees for credit transfer participants.

ARTICLE 3 DURATION OF AGREEMENT

This Agreement remain into force for a period of 3 (three) year being in effect from the date of signing of this MoA. It may be extended for any further period/s upon mutual consent in writing by both Parties.

ARTICLE 4 AGREEMENT OF PAYMENT

It is agreed to by both parties that the cost of this contract will be shared between UNY and Yala Rajabhat University as outlined in Article 2. Responsibilities.

ARTICLE 5 DISPUTE RESOLUTION

The First Party and The Second Party shall base their contractual relationship on the fundamental principles of goodwill and good faith. Any differing viewpoints and interpretations of this Agreement shall be settled by mutual consultation or negotiation.

ARTICLE 6 MISCELLANEOUS

- The agreement shall bind and inure to the benefit of the parties, their respective successors and permitted assigns.
- In the event of any conflict between this Agreement and any Exhibits hereto, the terms of this Agreement shall govern. This Agreement may only be ended in writing signed by both parties that explicitly states that it is intended to amend this Agreement.
- The Contract shall be effective and come into force when it is signed by both Parties. In witness where of authorized representative of the Parties here to have set their hands this day and year first above written
